

CELTIC-NEXT Autumn Call 2024 for ICT projects

FROM 1 July 2024 TO 21 October 2024.

Eureka is the world's biggest public network for international cooperation in R&D and innovation, present in over 45 countries. It is a decentralised intergovernmental organisation aiming to boost the productivity and competitiveness of industries by funding and supporting international collaborative market-driven R&D projects.

This call for projects has been launched following Eureka's Clusters framework based on mutual consent between participating national and regional funding bodies and Cluster organisations.

CELTIC-NEXT has opened a call for organisations collaborating internationally on the R&D of ICT projects. By applying and participating, your organisation can access national public funding for your R&D project.

The goal of this call for projects is to enable projects in the field of next-generation communications ICT for the digital society that contribute to a sustainable world.

You can submit your R&D project application between 1 July 2024 and 21 October 2024 by visiting CELTIC-NEXT website.

IMPORTANT NOTE:

For a CELTIC project, generally, the same funding conditions and funding rules apply as for a stand-alone Eureka project. As CELTIC is an endorsed Eureka cluster access to public funding is generally easier and faster for an independent proposal as the Public Authorities support the collaborative work programme of CELTIC and are more closely involved in providing the funding for proposals that have been CELTIC-labelled.

*Differently to the funding rules of an EU project (e.g. HorizonEurope program), there are **no common funds available that are shared among the successful proposals.***

Since **each country decides on own criteria on possible funding** it can happen that a project may not be able to start if one partner will not be funded. In those cases, provided such a partner will not consider self-funding, a project may either be restructured (e.g. by including another partner) or may be stopped.

Participation is open to companies of all sizes, universities and research organisations.

Eligibility

Eureka has limited eligibility criteria for organisations participating in a Clusters consortium:

- Your project idea must represent international cooperation in the form of a specific project.
- The project must be directed at researching or developing an innovative product, process or service with the goal of commercialisation.
- The project must have a civilian purpose.
- Your consortium must include at least two independent legal entities from a minimum of two Eureka countries.
- No single organisation or country can be responsible for more than 70% of the project budget.

If there is no allocated budget for your organisation type in your country and you want to participate in a project consortium, contact your national funding body using the form below to see whether there are other funding opportunities available or talk to them about self-funding.

Applying

1. Contact your national funding body and CELTIC-NEXT offices to discuss your project idea and eligibility.
2. Create an account on Clusters Projects Tool: <https://cluster-projects.eurestools.eu/>
3. Submit your CELTIC Project Proposal template (CPP) before the deadline, with the Confirmation Letter/Declaration of Acceptance (CLD) for each consortium partner within two weeks after your proposal submission.
4. If your project is selected, you will receive a positive Label Notification, a Project Cooperation Agreement (PCA) should be elaborated and signed between the consortium partners.
